

INSTITUTE OF HIGHER EDUCATION (IHE) COVID-19 PLAYBOOK



Colleges and universities are making plans to return to campus amid the continued public health concerns of COVID-19 while balancing campus life, health and safety. In response to soaring demand, The Coalition for College Cost Savings (Coalition) has partnered with HRP Associates, Inc. (HRP) to offer Coalition member schools a COVID-19 Playbook to aid campuses in their COVID-19 planning and preparedness. This Playbook has been prepared with input from HRP's team of Professional Engineers (PE), Certificated Safety Professionals (CSP), and Certified Industrial Hygienists (CIH) in conjunction with the latest guidance from organizations such as CDC, EPA and OSHA. This Playbook is presented to read as a template core plan that a college can augment with campus specific work instructions, inspections, policies and communications. Examples, instructions, practical tools and references are provided throughout the Playbook to guide the IHE in developing and implementing return-to-campus system that manages risks in balance with campus life and learning.

The training package is available to Coalition member schools for unlimited use for the 2020-2021 academic year by way of a campus specific coupon code which entitles access to HRP's Online Training Platform. Completion certificates are automatically issued.

In addition, the college will have access to one (1) hour of consultation with an HRP professional to provide initial guidance and support as well as one year of on-call service availability from HRP at preferred rates.

From time to time, EPA, OSHA, or CDC may offer updated or new guidance that may affect this Playbook. When this happens, HRP will provide a "push notification" to colleges and universities to maintain the plan relative to these updates.

The flat fee for the Playbook, associated examples, protocols, references, training, facilitation and push notifications is \$1,975.
