# Grant Funded Initiative for Independent College Transfer Underway at NEBHE, CCIC, AICUM, and AICURI

The New England Board of Higher Education (NEBHE) received a seven-month planning grant from The Teagle Foundation to formulate plans for a new transfer initiative between community colleges and independent colleges. The grant project is the first phase of building the foundation for a systematic transfer pathway from community colleges to four-year independent colleges in Connecticut, Massachusetts and Rhode Island, focused on the liberal arts.

NEBHE is partnering with the Connecticut Conference of Independent Colleges,

Association of Independent Colleges and Universities in Massachusetts and the Association of Independent Colleges and Universities of Rhode Island to begin establishing an admission transfer guarantee program.

"CCIC is thrilled to be collaborating with NEBHE and our colleagues at AICUM and AICU-RI on this important effort to promote transfer pathways for Connecticut community colleges students," said Jennifer Widness, President of CCIC. "Many community college students in Connecticut have found our member institutions to be an accessible and affordable option for transfer to complete their bachelor's degree in a timely manner. This new effort seeks to expand those opportunities for more seamless transitions, and allow even more transfer students to attend an institution in Connecticut that best meets their educational goals, and increases their opportunity to succeed."
