LAICU awarded Capacity-Building Grant from Council of Independent Colleges

The Louisiana Association of Independent Colleges and Universities (LAICU) has received a grant from the Council of Independent Colleges (CIC) for \$10,000 to fund a resource-development initiative for scholarship fundraising supporting students attending the nonprofit, private colleges and universities in Louisiana.



E&I Cooperative Services (E&I) held its annual Stockholders' Meeting via virtual conference on April 6, 2020.

The following financial and performance results were shared:

- Member purchases exceeded \$2.6 billion
- The Board voted to return \$2.3 million to members in the form of patronage refunds
- Members realized over \$200 million in savings by using E&I contracts

- Membership increased to over 5,200
- Member satisfaction reached a record high of 93% very or extremely satisfied

E&I's newly appointed CEO Eric Frank shared his appreciation for the Cooperative's mission and his vision for the future. "Education is undergoing a serious and sustained crisis – perhaps of unprecedented proportions – however, E&I was born in crisis," he said, referring to the Cooperative's inception in 1934 during the Great Depression. "I believe the opportunities for our members to reduce costs, preserve quality, and increase access to education are more important now than ever before. E&I will be a key partner in helping our members emerge from these challenging times, stabilize, and ultimately thrive."
