Plenary Session

Higher Education Governance for the Future of Connecticut Overview and Recommendations from Dr. Aims McGuinness

As Connecticut faces significant budget challenges as well as the opportunity for new leadership in the Office of Higher Education, **Aims McGuinness**, author of the recently released report from the Education Commission of the States (ECS), "State Policy Leadership for the Future: History of state coordination and governance and for the future", will discuss his findings and thoughts on what type of leadership, coordination and collaboration Connecticut needs to meet the goals of the state's Strategic Plan for Higher Education. The new ECS report notes that to the extent that the independent sector is a critical element of a state's capacity to meet its goals, policy and planning should recognize the contributions of that sector to the achievement of state goals.

Aims McGuinness is a Senior Fellow with the National Center for Higher Education Management Systems (NCHEMS), a private nonprofit policy center in Boulder, Colorado. At NCHEMS, he specializes in state governance and coordination of higher education; strategic planning and restructuring higher education systems; roles and responsibilities of public institutional and multi-campus system governing boards; and international comparison of education reform. Dr. McGuinness has also served as a consultant to Connecticut's Planning Commission for Higher Education since 2013.
